# Belle Creek Watershed Meeting August 31, 2016 1 PM at the SWCD Office

The Belle Creek Watershed District officers met on August 31, 2016 at 1 PM at the GCWD office in Goodhue. Members present were Chairman Les Kyllo, Treas. Jim Hedeen , Sec. Steve McNamara and Beau Kennedy.


Chairman Kyllo called the meeting to order.

Sec. and Treas. Reports were given and approved as read. Treas. Hedeen reported we have received our first half levy of 11,348.00 from Goodhue Co.

There was a short discussion on the unofficial Vangsness-Otterness dam that the beavers have plugged. The outlet pipe is still plugged and water is still running over the spillway. Beau reported the Soil and Water office is going to send Otterness a letter stating something has to be done to get the problem resolved.

Beau has finished taking the depth readings at Lake Willard. Will try to get a depth map made up before our next meeting in December.

Bruce Waugh is still trying to get the fencing-grazing project started at the Otterness structure. The newest plan is to put the fence across below the Rolph Otterness property, so a new cattle crossing has to be located. Also at the Otterness structure there is a discrepancy as to where the Watershed property lines are . Treas. Hedeen recommended we have a survey done to get them accurately marked in case we have to put up a new fence for the grazing project. That recommendation was sec. by Chairman Kyllo . Richard Otterness mentioned to Steve that the underground oil pipeline that crosses the stream just above the structure has about 20 feet of exposed pipe and the stream runs underneath the pipe. Beau will find out which oil company it is and send them a letter to get it fixed.



### **Belle Creek Watershed Meeting**

May 19, 2016

#### 1 PM at the Otterness Dam

The Belle Creek Watershed District officers met on May 19 at 1 PM at the Otterness dam. Members present were Chairman Les Kyllo and Sec. Steve McNamara. Also present were Beau Kennedy and Brad Anderson for part of the meeting. Jim Hedeen was absent.

Chairman Kyllo called the meeting to order.

Beau reported the easement for the McNamara structure is done and the county is working on the Hokanson easement. He spoke to Dan Ryan during the winter about crossing the water run. Dan preferred in a low ford crossing. Dan also wished to vacate the old easement. Regarding the Hokanson structure the NRCS is currently working on a grazing plan to accommodate more cattle and eliminate overgrazing. A letter from the BCWD to Chris to support the grazing plan and to continue to allow grazing may be helpful. Also some discussion on realigning paddocks with the property line. No action taken.

There is a new owner at the Duncan structure site. Beau will contact them and discuss how the Watershed rules and policies work.

This past winter Beau took some depth readings walking on the ice at Lake Willard. This summer he hopes to finish around the edges. When finished he will compile a depth map to show how much silt has accumulated.

The concrete-grout will be installed at the McNamara structure this summer as soon as the engineer from Rochester can come and oversee it.

After meeting Beau took us on a tour of another structure that is not officially part of our watershed system. It is what is known as the Vangness-Otterness dam and the beavers have plugged the outlet pipe and the water is running over the spillway
