# Goodhue Soil and Water Conservation District Board Meeting May 23, 2022

# **Environmental Quality Incentives Program (EQIP)**

9 initially pre-approved for funding.

7 applications (\$94,568) have moved to completion.

0 applications received for 2<sup>nd</sup> signup ended May 20th

# **Conservation Stewardship Program**

33 applications in Goodhue.
6 applications competed for funding
All 6 applications tentatively approved for funding (\$210,813)
Expecting contracts to be finalized by July 8<sup>th</sup>.

# NRCS Staffing in SE Area:

John Benjamin Wabasha DC will be on paternity leave starting in the next week – will be out of the office for 12 weeks. Goodhue county staff will be rotating to Wabasha to provide office coverage, as needed.

## **Conservation Reserve program**

24 offers for continuous sign-up.40 offers for general sign-up.Staff will be working on these soon.

#### **Existing EQIP and CSP projects**

Goodhue staff working to assist contract holders' complete projects – construction quotes are coming back at substantially higher prices than estimated.

This may limit the number of projects completed in 2022.
