# **Environmental Quality Incentives Program (EQIP)**

We are working on developing plans and ranking 41 EQIP applications tentatively approved for funding (9 in Goodhue). Contract obligation deadline is May 13<sup>th</sup>. 2<sup>nd</sup> signup has been announced with cutoff date of May 20<sup>th</sup>.

### **Conservation Stewardship Program**

Sign-up deadline for 2022 General CSP was February 4<sup>th</sup>. Completing interviews and planning with 48 applicants (35 in Goodhue). April 15<sup>th</sup> is assessment and ranking deadline. Contract deadline July 1<sup>st</sup>.
