



FEE SCHEDULE EFFECTIVE JANUARY 28, 2019

At the Goodhue County SWCD Board of Supervisors meeting held on January 28, 2019 the Board approved the following fee schedule for the Goodhue County SWCD office.

This is to inform you of the fee schedule set by the Goodhue County SWCD.

- 1. Labor costs for duplicating requested projects will be \$60.00 per hour.
- 2. Public Data Requests \$60.00 per hour labor costs-Minimum \$15.00
- 3. Fees for 10 photocopies or less will be \$1.00 per page.
- 4. Fees for 10 photocopies or more will be charged a labor fee of \$60.00 per hour plus \$.25 per page.
- 5. CPI Ratings \$25.00 per parcel
- 6. Radon Test Kit \$10.00
- 7. Water Test Kit \$60.00
- 8. Survey Flags \$10.00 (Includes Tax)
